


Statement on website falsely claim to be agent of CSC Futures (HK) Limited "CSC"

1. The full name of CSC is CSC Futures (HK) Limited;




- 3. CSC has never authorized any business partner to conduct business and has not authorized any person to use the above-mentioned trademark to act as an agent on behalf of CSC;
